2024 SUMMER SCHOOL Registration Process for Students Attending a Durham Catholic Secondary School

1. Students are to fill out the attached Summer School Travel for Credit course selection form with the assistance and approval of their home school Guidance Counsellor and Principal or Vice-Principal.
2. Completed forms must be signed by a student's parent or guardian and returned to DCDSB Continuing Education at credit.reg@dcdsb.ca or during office hours at 850 King St. W., Unit 26, Oshawa. **You will not be registered until you return this form to DCDSB Continuing Education and complete the EF Tour online registration and payment.**
3. Students will not be allowed to attend the summer school Travel for Credit without their school's approval. Guidance Counsellor and Administrator approval is mandatory.
4. Parent/Guardian must complete and submit the following additional forms:
 - Informed Consent
 - Waiver of Board Financial Liability for Student Excursions Form
 - Media Consent Form (optional)
 - If applicable, Administration of Oral Medication

Deadline for Application is March 22, 2024
